0503210	3	Financial management 1	-

This course introduces you to the world of Modern finance. It covers the concepts of time value of money, risk & return, estimate asset returns according to their risk characteristics, choose projects that maximize shareholder's wealth using a wide range of analytical tools. Specific topics include the introduction of financial management, the goals of financial managers , financial statements analysis , future value and present value calculations, valuation of long –term securities such as common stocks, preferred stock, and bonds, risk and return, capital structure, raising capital and the basic concepts of financial markets & institutions.

0503211	3	Financial management 2	Financial management 1

This is an advanced course of managerial finance. It covers the concepts of capital budgeting techniques (payback period, discounted payback period, the net present value, profitability index and internal rate of return), cost of capital: cost of bond before and after tax, cost of preferred stock, cost of common stock, and the weighted average cost of capital. Valuation of long –term securities, capital structure, and working capital Management.

Term structure of interest rates is also explored in addition to money market, bond market, stock market, commercial banks and financial institutions, and mutual funds.

0503463	3	Managerial economics	Microeconomics
Managerial Economics deals with the use of economic concepts and Decision Science methodology to solve managerial decision problem. In case of certain business conditions, the module uses Science techniques such as marginal analysis, linear programming as well as the method of LaGrange multiplier. Managerial economics also introduces statistical tools to solve Business problems in case of uncertainty. Also under risky business conditions managerial economics uses the probability theory, marginal utility theory as well as pricing theory to deal with such situation.

0503416	3	Small business finance	Financial management 2
This module introduces small businesses, their characteristics, life cycle, financial and non-financial constraints, main risks faced by these businesses, the role of banks in financing their needs, types of loans and guarantees provided for small businesses, reasons for their failure and default, and ways to solve or avoid these problems.

The understanding and analysis of psychological behavior and its impact on financial decision-making in all forms of market will be covered. It also aims to define and apply effective concepts and mechanisms to help enhance the financial decisions of investors.
